EXECUTIVE DIRECTOR'S REPORT – Dr. Rosendale stated that we will begin the interview process for a Business Manager and Human Resource Generalist. He said that we've received many applicants for both positions.

Dr. Rosendale said that we have started the renovation at the Rochester Building and we're hoping to be up and running by January.

SOLICITOR'S REPORT - Mr. Steff stated that we should be receiving the exoneration of tax letter for the Rochester site. He said everything is moving along, as expected.

OTHER BUSINESS - Before the Pledge of Allegiance, Mr. Miller asked everyone to remain standing in remembrance of Mrs. Bonnie Goehring, who recently passed away. Mrs. Goehring was a former Blackhawk School District and BVIU Board member.

Mrs. Niedbala advised the Board that we will be needing a new fire alarm system at New Horizon School. She stated that we have the money in the fund balance to cover the cost.

She talked about opening a Middle/High School Emotional Support classroom in the Rochester School District.

Mrs. Niedbala also stated that we would be needing two (2) additional Behavior Services positions in the Early Intervention program. This will be supported by a 5-year Beaver County Behavior Health AWARE Grant.
