The Beaver Valley Intermediate Unit Board of Directors held their regularly scheduled meeting on Wednesday, March 26, 2025 at 6:30 P.M.

ACTION TAKEN:

- 1. The bids for the 2025-2026 Joint Purchasing Program for copy paper were opened, recorded and turned over to the Joint Purchasing Committee for a meeting to be held on April 8, 2025, to determine bid award recommendations which will be submitted to the Board for consideration at the April 23, 2025, meeting.
- 2. The Board accepted the resignation of Mr. Christopher Brooks, Teacher Aide at New Horizon School effective March 31, 2025.
- 3. The Board employed Mr. Michael Simms, Monaca, PA as the full-time Business Manager Assistant, effective date to be determined.
- 4. Ms. Stephanie McJunkin, Hermitage, PA was employed as a full-time MDS Teacher at New Horizon North, effective date to be determined.
- 5. The Board employed Ms. Learsi Peralta, New Castle, PA as a full-time Shared Aide at New Horizon North, effective March 14, 2025.
- 6. Five (5) FMLA requests were approved by the Board.
- 7. In order to meet the requirement of providing Extended School Year (ESY) to eligible schoolage students with disabilities and to early intervention students that cannot have longer than a three week break in instruction, the Board approved staff members and substitutes listed below will be employed for the 2025 program. Teachers will be paid per their contractual daily rate. Teacher aides will be paid at the rate of \$100/day or at their contractual daily amount. In addition, Physical and Occupational therapies will be provided, as needed, through contracts with AOT, Inc., Dragonfly Pediatric Therapy, and Dedicated Staffing. The ESY program is funded through the Individuals with Disabilities Education Act (IDEA). There is no cost to the local school districts for BVIU ESY services. Students who attend New Horizon North will be charged for ESY services.
